Commissioner Dahlstedt - Words from Economic Analysis Results - Jim Smith Follow-up on Alternative Discussions - Salinity Intrusion Analyses - Stephen Pierce Update on Environmental Studies - Mike Scuderi to provide to Stephen Continued Discussion of Alternatives Next Steps - Timeline for decisions

My intent is to have Valerie really hammer home the point that we are in decision mode and must reach a consensus no later than the end of June. That means that we really only have two more meetings besides this one to get an agreement. So... here are my thoughts on what we should be planning for.

What other information would assist the group in making their decision?
- 5) Dave Brookings and I were thinking of seeing if Valerie could manage to get the group to eliminate 1/2 of the alternatives at the April meeting.
- 6) I think handouts of the cultural report (not the report itself but summaries like the end tables) would be good.
