Dear Mr. Stoker:

Thank you for your comments on our Skagit Levee and Channel Improvement Project public brochure.

As discussed on 12 May 1978 in a telephone conversation with your roommate, most of the information you requested is not yet available. We have completed most of our field surveys and foundation exploration and are currently developing the hydrologic model to determine the exact extent of the 100and 10-year flood plain. As stated in the public brochure, the alternative cost estimates were not based on detailed studies, but were preliminary engineering estimates of the range of costs that could be involved for each 1. L.M. W. L. M. ....... of the alternatives.

In regards to your request for information on 1975 flood damages, I have inclosed the introduction and the chapter on the Skagit River Basin from our report, dated June 1977, on the floods of December 1975 and January 1976 in Western Washington. This includes information on the floods, methods of flood damage analysis, and a breakdown on the flood damages by types.

I hope this information fulfills your needs.
